- The adoption of the demarcation and the specifications of the MAS;
- The requirements of the product quality of relevant components:
- The requirements of the network architecture;
- The field inspection of the performance- & other requirements of the MAS;
- The requirements of the security controls of the MAS;
- The assessment of the statistical data which is generated by the hardware and software of the MAS;
- The requirements of the Monitoring & Alarm Receiving Centre who collects the data and processes this according to the specifications of the MAS:
- The requirements of the corrective actions by the MAS on failing communication by the system.
- The requirements of the Alarm and Receiving Centre which handles the alarms.

Application and use

The goal of the product is to inform and alarm the (external) emergency organisation in a timely and secured way of the status of the good(s) or person(s) to be able to start the emergency process. The reliability and availability of the system is essential. The product is intended to be used in the field, on sites and/or in appointed buildings as additional function to send information of the good(s) or person(s) in specific situations to the (external) emergency organisation if needed. The infrastructure is the same for the protection of vehicles and goods and persons. The requirements for vehicles and goods (e.g. logistics) and persons are divided in separate chapters. For vehicles and goods many requirements are determined. That's why this certification scheme does not set extra requirements. The chapter about persons has a functional separation in four scopes.
