

- The product may be fully new or 'not recognized yet'.
- The characteristic is outstanding.
- The seller may be the OEM, a Private Label owner, a trader or...

• The <u>Kiwa Covenant Manual</u> is the manual and template for the individual product or process to be certified.

The Covenant process knows three fases:

Fase 1: Writing the Covenant

- Describe the claim including the tests/research (*) needed to substantiate the claim.
- Admin and Project management.
- Quality control by Kiwa Covenant Committee.
- (*) tests and research against or based on existing standards

The Covenant process knows three fases:

Fase 2: Initial Certification process

- Audit quality system and process and sample taking
- Testing
- Evaluation of test/research, reporting, finalizing, review and issue of covenant (certificate)

The Covenant process knows three fases:

Fase 3: Yearly monitoring


- Audits 2/y.
- Admin and project management.
- Tests according frequency determined in F1.
