General information:

The current legal framework for organic production includes some exceptional production rules that are strictly necessary for organic production to continue or recommence. Nevertheless, those derogations should be limited in time and only be granted to the affected types of production, or, where relevant, land parcels, and to all relevant operators in the area concerned, or to the individual operator covered by the formal decision.

The majority of them may be applied in case of catastrophic circumstances for plant, livestock, beekeeping, and aquaculture production because when operators1 are affected by catastrophic circumstances, they cannot ensure the total fulfilment of the regulation, and some exceptions are needed to continue or recommence the organic production.

In this frame, catastrophic circumstances are any extraordinary events or emergencies that can affect the certification body and its certified operators. This kind of event could be derived from an 'adverse climatic situation', 'animal diseases', an 'environmental incident', a 'natural disaster' or a 'catastrophic event', as well as any comparable situation, that Kiwa BCS recognizes a situation as catastrophic circumstances based on a statement issued by the relevant authorities of the third country in which the situation occurs or by evaluation based on official organizations justifying the catastrophic circumstances.

If the operation that you are in charge of is affected by a similar situation, you must request the recognition of a catastrophic circumstance and, if it applies, request one of the following derogations.

1. For the use of non-organic animals to renew (or reconstitute) the herd or flock in the case of high mortality of animals and when organically reared animals are not available, provided that the respective conversion periods specified in point 1.2.2 of Part II of that Annex II (Reg (EU) 2018/848) are complied with. It also applies to the production of bees and other insects.

2. For the use of non-organic feed instead of organic or in-conversion feed in livestock production when feed production is lost or restrictions are imposed.

3. For the adaptation to grazing on organic land, the stocking density in buildings and minimum surfaces for indoor and outdoor areas when the production unit of livestock is affected.

4. For the reduction of the percentage of the dry matter consisting of roughage, fresh or dried fodder, or silage in daily rations provided that the animal's nutritional requirements at the various stages of its development are met when feed production is lost or when restrictions are imposed.

5. For feeding bee colonies with organic honey, organic pollen, organic sugar syrups, or organic sugar when the survival of the colony is endangered for other reasons than climatic conditions.

6. For moving bee colonies in areas not respecting the provisions for the placing of the apiaries when the survival of the colony is endangered,

7. For the use of non-organic aquaculture animals to renew (or reconstitute) the aquaculture stock in case of high mortality of aquaculture animals and when organically reared animals are not available, provided that the latter two-thirds of the duration of the production cycle are managed under organic management.

<u>Please submit this application to Kiwa BCS **prior** to executing any of the activities described above. Otherwise, the derogation cannot be granted, and the operation will restart the conversion period if it applies.</u>
