Regulatory Alert - Mexico

Public consultation on draft regarding 57-64GHz band for free use

Further to PCS' Regulatory Alert released on 22nd November 2016, Mexican Regulator *Instituto Federal de Telecomunicaciones* (IFT) have released a statement on their website advising that a public consultation is underway concerning the draft regulation for the classification of the 57-64GHz band for free use.

Currently, Approvals for Short Range Devices (SRD's) can be filed and approved under international recommendations ITU-R M.2003-1 and SM.2153-5. With this draft, a Mexican standard is being allocated for the use of this band.

Notable proposals contained in the draft are as follows:

- To establish operating conditions for the use of the 57-64 GHz band as free spectrum.
- Type Approval applications for devices, equipment or products operating in this frequency band will need to be filed to IFT.
- The proposal draft takes into consideration various standards by the ITU, ECMA, CEPT, IEEE and ETSI for the 57-64 GHz band.

Some of the restrictions mentioned in the draft are as follows:

• Equipment or devices used in aircraft or satellites, field disturbance sensors, which include vehicle radar systems, except such sensors that are used for: fixed operations, among others, are not permitted to operate in the 57-64 GHz band.

The public consultation officially opened on 10th February and will close on 9th March.
