Regulatory Update

India – Draft Guidelines for Series Approval of Products for Implementation of "Electronics and Information Technology Goods (Requirements for Compulsory Registration) Order, 2012" – Phase III

Further to our regulatory update issued on 30th August 2017 on the Phase III expansion of the BIS scheme, PCS has learned that the Ministry of Electronics and Information Technology (Meity) and the Bureau of Indian Standards (BIS) in India have attended a Technical Advisory Committee meeting where they deliberated draft guidelines for series approval for products covered under Phase III.

Under this draft, series approval can only be considered where -

1 – Products under Categories 31 to 35 up to a range of rated power will be allowed in the series, provided conditions set for each category are met.

2 - Products under Category 36 up to a range of output power rating will be accommodated in the series, provided conditions set for each category are met.

3 – Product under Categories 37 to 43 will be grouped as one series provided conditions set for each category are met.

PCS will continue to monitor this development and will provide a further update once the draft guidelines have become officially published.
